## CREDIT REQUIREMENTS

<b>Qualifying Credit Score:</b>	<ul style="list-style-type: none"> <li>Primary wage earner must have at least 2 scores and is used to determine the overall loan qualifying credit score. <ul style="list-style-type: none"> <li>✓ If three scores are provided, use middle score</li> <li>✓ If two scores are provided, use lowest score</li> <li>✓ If one score is provided, the borrower is not eligible</li> </ul> </li> <li>Each additional borrower must have at least one score. <ul style="list-style-type: none"> <li>✓ If three scores are provided, at least one must be 620+</li> <li>✓ If two scores are provided, at least one must be 620+</li> <li>✓ If one score is provided, it must be 620+</li> </ul> </li> <li>When qualifying income is equal for all borrowers the highest representative score is used to determine the loan qualifying score.</li> <li>When the transaction includes a non-occupying coborrower the qual score of the occupying borrower is used.</li> <li>For Asset Depletion doc type, the lowest overall borrower representative score is used to determine the loan qualifying score.</li> </ul>
<b>Tradelines:</b>	<ul style="list-style-type: none"> <li>Tradeline requirement based on primary wage earner.</li> <li>Borrowers with 3 credit scores: <ul style="list-style-type: none"> <li>✓ No minimum tradelines required</li> </ul> </li> <li>Borrowers with 2 credit scores: <ul style="list-style-type: none"> <li>✓ 3 tradelines reporting for 12+ months with activity in the last 12 months; OR</li> <li>✓ 2 tradelines reporting for 24+ months with activity in the last 12 months; OR</li> <li>✓ 1 mortgage or installment tradeline reporting for 36+ months with activity in the last 12 months .</li> </ul> </li> <li>To qualify as a valid tradeline, the following requirements apply: <ul style="list-style-type: none"> <li>✓ Must be reflected on credit report. (An acceptable 12- or 24-month housing history, not reporting on credit, may also be used as a tradeline.)</li> <li>✓ Must have activity in the past 12 months and may be open or closed.</li> <li>✓ Max 0 x 60 x 12.</li> </ul> </li> <li>Credit lines on which the borrower is not obligated to make payments are not acceptable. Examples include loans in a deferment period, collection or charged-off accounts, accounts discharged through bankruptcy, and authorized user accounts.</li> <li>Student loans can be counted as tradelines if they are in repayment and are not deferred.</li> <li>Insufficient tradelines and non-traditional credit is not allowed. Each borrower must have a valid and usable score.</li> </ul>
<b>Housing Events:</b>	<ul style="list-style-type: none"> <li>A Housing Event is any one of the following events listed below: <ul style="list-style-type: none"> <li>✓ Foreclosure, Deed-in-Lieu, or Short Sale measured from the date of completed sale or final property transfer. The Housing Event must be completed prior to loan closing with no outstanding deficiency balance remaining.</li> <li>✓ 1x120 mortgage late measured from the date the mortgage was brought current.</li> <li>✓ Modification measured from the date the modification was executed which resulted in: <ul style="list-style-type: none"> <li>• Forgiveness of a portion of principal and/or interest on either the first or second mortgage.</li> <li>• Application of a principal curtailment by or on behalf of the investor to simulate principal forgiveness.</li> <li>• Conversion of any portion of the original mortgage debt to a "soft" subordinate mortgage.</li> <li>• Conversion of any portion of the original mortgage debt from secured to unsecured.</li> </ul> </li> </ul> </li> <li>If the property was surrendered in a Chapter 7 bankruptcy, the bankruptcy discharge date is used for seasoning. Bankruptcy papers may be required to show the property was surrendered. The foreclosure action is not required to be fully complete.</li> </ul>

## CREDIT REQUIREMENTS (continued)

<b>Housing History:</b>	<ul style="list-style-type: none"> <li>• A 12-month mortgage history is required for all financed properties owned by the borrower.</li> <li>• A 12-month rental history is required when the borrower is renting their current primary residence.</li> <li>• Institutional housing payments not reflected on the credit report may be documented as follows: <ul style="list-style-type: none"> <li>✓ Verification of Rent (VOR) or Verification of Mortgage (VOM) form; OR</li> <li>✓ Lender generated payment history showing paid dates and due dates; OR</li> <li>✓ Mortgage statements for the review period if they indicate the due date which each payment was applied to; OR</li> <li>✓ Credit supplement through the same credit reporting agency as the original credit report.</li> </ul> </li> <li>• Non-Institutional housing payments not reflected on the credit report may be documented as follows: <ul style="list-style-type: none"> <li>✓ Verification of Rent (VOR) or Verification of Mortgage (VOM) form; OR</li> <li>✓ Lender generated payment history showing paid dates and due dates; OR</li> <li>✓ Mortgage statements for the review period if they indicate the due date which each payment was applied to; OR</li> <li>✓ Credit supplement through the same credit reporting agency as the original credit report; AND</li> <li>✓ Most recent 12 months cancelled checks or bank statements. (Note, these must be accompanied with one of the items listed above they are not sufficient alone.)</li> </ul> </li> <li>• A combined total of all late mortgage and rental payments in the past 12 months must be used to determine the housing history.</li> <li>• All mortgages and rental payments should be current at time of closing. If the credit report or VOR/VOM reflects a past-due status, updated documentation is required to verify account is current.</li> <li>• All mortgages being paid off in a refinance or new-construction purchase transaction must have a verified, monthly payment history. Mortgages with deferred payments are not eligible.</li> <li>• Borrowers who live rent-free are allowed with the following restrictions: <ul style="list-style-type: none"> <li>✓ Max 85% LTV</li> <li>✓ 3 additional months reserves required.</li> <li>✓ 10% minimum borrower contribution.</li> <li>✓ Borrower(s) who own their primary residence free and clear are not considered living rent-free.</li> </ul> </li> <li>• Borrowers unable to document a complete 12-month housing history are allowed with the following restrictions: <ul style="list-style-type: none"> <li>✓ Max 85% LTV</li> <li>✓ 3 additional months reserves required.</li> <li>✓ 10% minimum borrower contribution.</li> <li>✓ Any available portion of a 12-month housing history must be obtained and paid as agreed.</li> </ul> </li> </ul>
<b>Charge-Offs and Collections:</b>	<ul style="list-style-type: none"> <li>• The following accounts may remain open: <ul style="list-style-type: none"> <li>✓ Collections and charge-offs &lt; 24 months old with a maximum cumulative balance of \$2,000</li> <li>✓ Collections and charge-offs ≥ 24 months old with a maximum of \$2,500 per occurrence</li> <li>✓ All medical collections</li> </ul> </li> <li>• Collection and charge-off balances exceeding the amounts listed above must be paid in full.</li> </ul>

## CREDIT REQUIREMENTS (continued)

<b>Judgments and Tax Liens:</b>	<ul style="list-style-type: none"> <li>• All judgments or liens affecting title must be paid.</li> <li>• Written explanation from the borrower for any judgments, garnishments, or liens less than 10 years old is required.</li> <li>• Active court-ordered judgments may remain open when one of the following options are met: <ul style="list-style-type: none"> <li>✓ The amount is the lessor of \$5,000 per occurrence or 2% of the loan amount: OR</li> <li>✓ The borrower is currently in a repayment agreement with the creditor. All of the following requirements must be met: <ul style="list-style-type: none"> <li>▪ A copy of the repayment agreement is obtained,</li> <li>▪ A minimum of 3 months has elapsed on the plan,</li> <li>▪ Evidence of timely payments for the most recent 3 months is provided, and</li> <li>▪ The maximum payment required under the plan is included in the DTI.</li> </ul> </li> </ul> </li> <li>• Outstanding state and federal tax liens or delinquent obligations may remain open on purchase transactions only (additional LTV reductions may be required based on the size of the lien). <b>First Time Investor:</b>	<ul style="list-style-type: none"> <li>• Defined as: Borrower(s) who have not owned and managed commercial or non-owner occupied residential real estate in the United States for at least 1 year in the last 3 years.</li> <li>• Eligible with no LTV restrictions.</li> </ul>			
<b>First Time Homebuyer:</b>	<ul style="list-style-type: none"> <li>• Defined as: Borrower(s) who have not owned at least one residential property in the United States in the last 3 years.</li> <li>• Primary Residence and Second Homes: Eligible with no restrictions.</li> <li>• Investment Property: Eligible with restrictions, see overlays.</li> </ul>

<b>Non-Occupant Co-Borrowers:</b>	<ul style="list-style-type: none"> <li>Non-occupant borrowers are credit applicants on a principal residence transaction who do not occupy the subject property.</li> <li>Occupying borrower(s) must have a DTI ratio of 60% or less. This excludes the income/debts of non-occupant borrower(s).</li> <li>Cash out transactions not allowed.</li> <li>The non-occupant co-borrower must be included on title of the subject property.</li> <li>Non-Permanent Resident Aliens, Asylum &amp; DACA: Not Permitted.</li> </ul>
<b>Perm Resident Alien:</b>	<ul style="list-style-type: none"> <li>A permanent resident alien is a non-U.S. citizen authorized to live and work in the U.S. on a permanent basis. Permanent resident aliens are eligible for financing.</li> <li>Acceptable evidence of lawful permanent residency must be documented and meet one of the following criteria: <ul style="list-style-type: none"> <li>✓ I-151 – Permanent Resident Card (Green Card) that does not have an expiration date</li> <li>✓ I-551 – Permanent Resident Card (Green Card) issued for 10 years that has not expired</li> <li>✓ I-551 – Conditional Permanent Resident Card (Green Card) issued for 2 years that has an expiration date and is accompanied by a copy of USCIS Form I-751 requesting removal of the conditions</li> <li>✓ Un-expired Foreign Passport with an un-expired stamp reading as follows: “Processed for I-551 Temporary Evidence of Lawful Admission for Permanent Residence. Valid until mm-dd-yyyy. Employment Authorized.”</li> </ul> </li> </ul>
<b>Non-Perm Resident Alien:</b>	<ul style="list-style-type: none"> <li>Lawful non-permanent residents are legally accorded the privilege of residing temporarily in the United States.</li> <li>2 years US residency &amp; employment history required, with valid Social Security Number and US credit.</li> <li>Validation that borrower has employment authorization is required with <b>one</b> of the following: <ul style="list-style-type: none"> <li>✓ A valid current Form I-766 Employment Authorization Document (EAD) work permit/card. <ul style="list-style-type: none"> <li>▪ The EAD may not expire within 6 months of loan application date. (If the EAD will expire within 6 months of loan application, it is acceptable to obtain a letter from the employer documenting the borrower’s continued employment and continued EAD renewal.)</li> <li>▪ The EAD documentation is acceptable up to 540 days if an automatic extension has been granted.</li> </ul> </li> <li>✓ Form I-765 Application for Employment Authorization. The form must reflect approval status in the Action Block (upper right-hand corner)</li> <li>✓ Form I-797, I-797A, or I-797B or I-797C conveying approval status.</li> <li>✓ Employment authorization may also be evidenced by certain VISA types.</li> <li>✓ Copy of borrower’s passport is not required.</li> </ul> </li> </ul>
<b>Asylum:</b>	<ul style="list-style-type: none"> <li>Individuals granted asylum are eligible for financing.</li> <li>2 years US residency &amp; employment history required, with valid Social Security Number and US credit.</li> <li>Validation that borrower has employment authorization is required with <b>one</b> of the following: <ul style="list-style-type: none"> <li>✓ A valid current Form I-766 Employment Authorization Document (EAD) work permit/card referencing Category C08. <ul style="list-style-type: none"> <li>▪ The EAD may not expire within 6 months of loan application date. (If the EAD will expire within 6 months of loan application, it is acceptable to obtain a letter from the employer documenting the borrower’s continued employment and continued EAD renewal.)</li> <li>▪ The EAD documentation is acceptable up to 540 days if an automatic extension has been granted.</li> </ul> </li> <li>✓ Form I-765 Application for Employment Authorization. <b>DACA:</b>	<ul style="list-style-type: none"> <li>Individuals who can provide documentation of current DACA status along with work authorization are eligible for financing under the same criteria as a non-permanent resident.</li> <li>2 years US residency &amp; employment history required, with valid Social Security Number and US credit.</li> <li>Validation that borrower has employment authorization is required with one of the following: <ul style="list-style-type: none"> <li>✓ A valid current Form I-766 Employment Authorization Document (EAD) work permit/card referencing Category C33. <ul style="list-style-type: none"> <li>▪ The EAD may not expire within 6 months of loan application date.</li> <li>▪ The EAD documentation is acceptable up to 540 days if an automatic extension has been granted.</li> </ul> </li> <li>✓ Form I-765 Application for Employment Authorization. The form must reflect approval status in the Action Block (upper right-hand corner)</li> <li>✓ Form I-797, I-797A, or I-797B or I-797C conveying approval status.</li> </ul> </li> <li>✓ Copy of borrower's passport is not required.</li> </ul>

<b>Asset Verification:</b>	<ul style="list-style-type: none"> <li>Assets must be seasoned for 30 days or sourced.</li> <li>Assets must be verified with one of the following: <ul style="list-style-type: none"> <li>✓ Account statements for the most recent month or quarter indicating opening and closing balances.</li> <li>✓ Written Verification of Deposit (VOD) completed by the financial institution.</li> <li>✓ Statements provided by third-party asset verification companies (e.g., AccountChek, Finicity, Plaid) if the vendor participates in FNMA Day 1 Certainty.</li> </ul> </li> </ul>
<b>Large Deposits:</b>	<ul style="list-style-type: none"> <li>Defined as follows: <ul style="list-style-type: none"> <li>✓ Bank Statement Doc Type: Any single deposit greater than 50% of the borrower's monthly gross qualifying income prior to reductions for ownership or expense factor.</li> <li>✓ All Other Doc Types: Any single deposit greater than 100% of the borrower's monthly qualifying income from page two of the 1003.</li> </ul> </li> <li>Refinances: Not sourced.</li> <li>Purchases: Sourced as follows: <ul style="list-style-type: none"> <li>✓ If personal accounts are used for assets, large deposits as defined above must be sourced.</li> <li>✓ If business accounts are used for assets and income, large deposits as defined above must be sourced.</li> <li>✓ If business accounts are used for assets but not used for income, large deposits as defined above do not need to be sourced.</li> </ul> </li> <li>Unsourced assets, assets seasoned for less than 30 days, and unexplained deposits exceeding 100% of the borrower's qualifying monthly income are allowed if the total amount is less than or equal to 10% of the total funds required to close.</li> </ul>

<b>Borrower Contribution:</b>	<ul style="list-style-type: none"> <li>• Primary with verified housing history: 5% of sales price.</li> <li>• Primary with unverified housing history: 10% of sales price.</li> <li>• Second Homes: 5% of sales price.</li> <li>• Investment Property: 10% of sales price.</li> <li>• Gift of Equity transaction with verified housing history: No Minimum.</li> <li>• Gift of Equity transaction without verified housing history: 10% of sales price</li> </ul>

Acceptable documentation includes any of the following: <ul style="list-style-type: none"> <li>✓ Copy of the donor's check or withdrawal slip and the borrower's deposit slip</li> <li>✓ Copy of the donor's check to the closing agent</li> <li>✓ Evidence of wire transfer from donor to borrower</li> <li>✓ Settlement statement showing receipt of the donor's check</li> </ul> </li> <li>• When the funds are not transferred prior to closing, it must be documented that the donor gave the closing agent the gift funds in the form of a certified check, a cashier's check, money order, or wire transfer.</li> </ul>
